1. This tournament has two divisions, Open Division and Women's Division. It is each bowler's responsibility to have a current USBC sanction card prior to bowling any event. Associate membership and participation fee may be paid at the tournament site prior to bowling.
2. Prize fund ratio for Team, Doubles and Singles will be one (1) prize for every twenty (20) entries. All prizes money will be awarded thirty (30) days after the conclusion of the tournament.
3. Each Bowler will use the highest book average of 2022-2023 with a minimum of twenty-one (21) games. If no book average is published, verification form your local association will be required. Summer average will be used. Sport shot averages will be used with the converted average listed on bowl.com. Youth averages will be accepted. However, no youth bowlers may participate in this tournament. The Ten Pin Rule does not apply in this tournament.
4. It is the bowler's responsibility to use the correct average. If the submitted average is lower than what is listed on bowl.com then the bowler is disqualified. USCB Rule 319 a, b, c and e will be strictly enforced. Failure to comply with all rules shall cause forfeiture of all entry fees, scores, and prize money.
5. The handicap will be based on $75 \%$ of the difference of the team's average from the base in each event. The base for handicapping is Team: 1100, Doubles: 440, Singles: 220. The minimum average for handicapping in each event will be follows: Open Division: Team 700, Doubles 280, Singles 140. Women's Division: Team 575, Doubles 230, Singles 115.
6. Only two (2) professional bowlers per team and only one per Doubles set will be permitted.
7. Bowlers do not need to report previous tournament winnings. It is the bowler's responsibility to report if they have ever been subject to adjusted or re-rated average or refused an adjusted or re-rate average in the past two years.
8. All protests must be made in writing by January 3, 2024.
9. In the event of a mechanical failure, it is hereby agreed that the bowlers affected shall be moved to the next available pair of lanes.
10. Bowlers will be allowed ten (10) minutes of practice in Team and Singles, and no practice in Doubles.
11. Storm Jackets will be awarded to the Team, Doubles and Singles Champions in each division.
12. Reservations can be made by filling out a reservation form. Entry closing date is September 15, 2023. If full payment is not received by this date, then reservation will be declared void and assigned to the next available entry. No entry will be refunded after September 15, 2023. Late entries may be accepted based on Tournament Director discretion.
13. All substitutions must be made with tournament management twenty-four (24) hours prior to bowling each event. NO CHANGES TO THE LINEUP WILL BE PERMITED, SUBSTITUTES MUST BOWL IN THE SAME POSITION AS THE ORIGINAL MEMBER LISTED ON THE TOURNAMENT ENTY. Emergency substitution may be made 1 hour prior to the start of the squad.
14. Bowlers must bowl Doubles and Singles, or neither. Once the squad is started, no make-up frames will be allowed by tardy bowlers. Zero will be given for all frames missed.
15. All employees of Andy B's and Broken Arrow Lanes will be eligible to participate in this tournament.
16. Premature termination of this tournament due to war, national emergency, fire, strikes, lockouts, labor difficulties, or other reason beyond the control of the management of this tournament shall cause prize schedules to be pro-rated with the number of entries who have bowled in each event up to the time of termination.
17. THE TOURNAMENT MANAGER RESERVES THE RIGHT TO REJECT ANY ENTRY AND CANCEL THIS EVENT AT ANYTIME.
18. ***BOWLERS MAY ENTER TEAM EVENT MULTIPLE TIMES, provided not more than three (3) members of the original team bowls on the other entries. When multiple participation is permitted, the bowlers first appearance in each event shall count toward their All Events.
19. ***BOWLERS MAY ENTER DOUBLES/SINGLES TWICE. Women may bowl doubles and singles once in each division or twice total. Men may bowl in Open Division twice as long as you change your doubles partner. Bowlers may only cash once in singles in each division.
20. If you pay for All Events in the Open Division, you must bowl all three (3) events in the Open Division. If you pay for All Events in the Women's Division, you must bowl all three (3) events in the Women's Division.
21. Dress Code: hats, shirts, or clothing of any kind with profanity or objectionable artwork will not be permitted. The bowler or guest that is not in compliance with the dress code will be asked to leave the location.
22. Unsportsmanlike conduct will not be tolerated. Bowlers will be required to leave the bowling center and will receive zeros for the remainder of the tournament with no refund.

CHECK-IN PROCEDURES All bowlers are responsible for checking themselves in and obtaining lane assignments via the bulletin board. Lane assignments will be posted one (1) hour prior to squad time.
